

It's been referred to as "the poor man's marble, because of having been used in churches for statuary. Today it's commonly the material in Venetian carnival masks. He has also been looking at automata.

Baron Albrecht: Working on 15th & 16th century quivers, of Italian and Middle-eastern type; also SCA suitable fretted zither music

Official archery practices are resuming on March 6th, after the Omicron pause. Whether it's sunny or snow falling, we will continue to have archery practice outdoors. But spring is near. In just two more months, twice weekly practices will resume.

Hwæt, let us celebrate the first day of Spring with a hiking in the warming outdoors. We will gather at the Megon Nature Center, where there are several trails through its 438 acres. Parking and park are free to enter. The parking lot is a tenth of a mile west of the intersection of County Line Rd and Highway 181 (76th Street in Milwaukee/Wauwatosa Rd in Mequon). Hiking in garb is encouraged, but dress for your comfort and safety.

In the event that the trails are too muddy or icy, the hike will be moved to Lapham Peak State Park in Delafield, where we can hike on the paved path. Arnbjørn will inspect the MNC on Saturday to determine if it good to hike on, and announce on the CAM List and Facebook, where Sunday's hike will be.

If it is raining, we will reschedule for another day.

The Kingdom of Northshield of The Society of Creative Anachronism Effective March 2021 (AS LV)

I. An Introduction to the Society for Creative Anachronism (SCA)

- A) The Society for Creative Anachronism (SCA) is an international, not-for-profit educational organization devoted to the study and re-creation of the pre-17th-century World. The members of the SCA endeavor to recapture the ambiance of the Middle Ages and the Renaissance and to rekindle the lost ideals of chivalry, courtesy, honor and graciousness.
- B) Participants study medieval martial arts, costuming, armor making, leather work, archery, heraldry, metalwork, vinting and brewing, cooking, dancing, calligraphy, manuscript illumination, needlecrafts, music and much more. Feasts, tournaments, dances, guilds and classes are just a few of the many activities offered by the SCA.
- C) The local Society chapter, called the Barony of Caer Anterth Mawr, has membership from Milwaukee, Waukesha, Ozaukee, Racine, Kenosha, Jefferson, and Washington counties, which comprise all ages and interests.

II. The Mission Statement of Caer Anterth Mawr

Caer Anterth Mawr is dedicated to providing an atmosphere of learning, sharing, growth and recognition through the studies and re-enactment of Medieval Life by providing quality events, programs, activities and services to its members and prospective members, and by a commitment to the retention and recruitment of its members.




